- October 18, 2024** Website Posting of CoC Application, CoC Prioritization Listing, and Project Applications and Public Posting Announcing the Availability of CoC Application Documents for Public Comment and Review.
- October 24, 2024** CoC Approval of Consolidated Application via online vote of the OAEH Executive Board.
- October 30, 2024** HUD COC Application Submission Deadline (*The City of Springfield serves as Lead Agency for the OAEH and will submit the HUD CoC Application on Monday, October 28, 2024*)
