1. Provide a description that addresses the entire scope of the proposed project.

CCSOMO's RRH Program seeks to move homeless families as quickly as possible into permanent housing and achieve stability in housing following a Housing First model which does not set preconditions to entry such as sobriety or minimum income threshold. Focus is to reduce barriers so clients can become stably housed and not easily terminated from services. CCSOMO receives referrals from Coordinated Entry which completes screening and assessments including the VI-SPDAT II vulnerability index and sets prioritization based on vulnerability score. Coordinated Entry contacts CCSOMO through the HMIS system to make referrals, and case conferencing occurs every other week with CoC grant recipients to share resources and strategies to help house clients facing significant barriers. CCSOMO provides clients with housing stability case management, rental and financial assistance, access to supportive services including assistance in attaining mainstream benefits and community resources to achieve stability in housing. RRH program serves Christian, Greene and Webster counties, and the Springfield Community Focus 2021 which researched the region discovered a shortage of accessible housing and opportunities for renters with evictions or low credit scores. The number of homeless families with children seeking shelter through Coordinated Entry continues to climb with over 500 requests last year and few emergency units available. Based on CCSOMO's experience with HUD CoC RRH, SSVF and ESG, not only is there an identified need, but many are waiting for assistance including homeless veterans who do not qualify for SSVF, families residing in emergency shelters, those fleeing domestic violence and who are literally homeless. CCSOMO reaches out to landlords to establish relationships that lead to lower barriers for clients. Eligibility criteria entering the program coming from the streets, emergency shelters, institutions or transitional housing must be met with client data entered into HMIS. Targeted populations are homeless families especially those who are chronically homeless, veterans, households with members who have substance abuse, mental illness or other disabilities. CCSOMO case managers work with clients in a holistic and individualized manner using a family strengthening model that empowers clients in the decision-making process. This individualized approach allows case managers to work with a client to find housing type, scale and location that fit clients' needs. Case managers follow FMR, habitability standards and rent reasonableness standards when assisting clients in housing search and evaluating lease agreements. Outcomes measured are number of households stably housed when rent assistance ceases and at follow-up, number of households that increased household income either through employment or access to mainstream benefits, number of households who become gainfully employed and achieved self-sufficiency and number referrals for supportive services. In January of 2023, Catholic Charities entered into a partnership with Elevance Health for a pilot program to provide temporary housing for homeless individuals who are released from the hospital to ensure adequate time for recovery. During this time CCSOMO case managers seek housing options through other grant funds and provide resources and services to increase stability and self sufficiency for this particularly vulnerable population...

This letter serves as Catholic Charities of Southern Missouri, Inc.'s (CCSOMO) commitment to meet the matching fund requirements for its HUD Continuum of Care Program grant for CoC MO-600. CCSOMO agrees to provide \$38,000 of cash match.

The match amount will be broken down as follows:
