### 3B. Project Description

**1. Provide a description that addresses the entire scope of the proposed project.**

CCSOMO's RRH Program moves homeless families quickly into permanent housing and helps them achieve housing stability following a Housing First model which does not set preconditions to entry such as sobriety or minimum income threshold. The focus is to reduce barriers so clients can become stably housed and not easily terminated from services. CCSOMO receives referrals from Coordinated Entry which completes the screening and assessments. Case managers provide clients with housing stability case management, rental and financial assistance and access to supportive services including assistance in attaining mainstream benefits and community resources to achieve housing stability. RRH program serves Christian, Greene and Webster counties, and the Springfield Community Focus 2021 through research discovered a shortage of accessible housing and opportunities for renters with evictions or low credit scores. From September 5, 2023, to September 3, 2024, 2,043 of the calls to 211 for Webster, Greene and Christian were for housing/shelter assistance. Among those calls were 1,060 for rent assistance.

Based on CCSOMO's experience with SSVF and ESG, not only is there an identified need, but many are waiting for assistance including homeless veterans who do not qualify for SSVF, individuals and families residing in emergency shelters located in the region, those fleeing domestic violence and those who are literally homeless. CCSOMO does outreach to connect with homeless and those at-risk households and offers services that can result in stable permanent housing. CCSOMO reaches out to landlords to establish relationships that can lead to lower barriers for clients. Homeless individuals and families served under this program must meet eligibility criteria on entering the program coming from the streets, emergency shelters, safe havens and institutions or transitional housing. Client data is entered into HMIS. Targeted populations are chronically homeless, veterans, families with children, elderly and individuals or households with members who have substance abuse, mental illness or other disabilities. CCSOMO case managers work with clients in a holistic and individualized manner using a family strengthening model that empowers clients in the decision-making process. This individualized approach allows case managers to work with clients to find housing type, scale and location fitting the needs of clients. Case managers follow FMR, habitability standards and rent reasonableness standards when assisting clients in housing search and evaluating lease agreements. Outcomes measured are number of households stably housed when rent assistance ceases and at follow-up, number of households with increased household income either through employment or access to mainstream benefits, number of households who became gainfully employed and achieved self-sufficiency and number referrals for supportive services.

In January 2023, Catholic Charities entered a partnership with Elevance Health for a program to provide temporary housing for homeless individuals who are released from the hospital to ensure adequate time for recovery. During this time, case managers seek housing options through other grant funds and provide resources and services to increase stability and self-sufficiency for this particularly vulnerable population.


