### **3B. Project Description**

**1. Provide a description that addresses the entire scope of the proposed project.**

This legacy Shelter Plus Care (SPC) program exemplifies evidence-based best practices for Permanent Supportive Housing (PSH) serving persons who are experiencing unsheltered, chronic homelessness impacted by severe mental illness, substance use disorder and co-occurring diagnoses. The 2020 Ozarks Alliance to End Homelessness Point-in-Time Report shows that 87 people were chronically homeless. We serve people with multiple service needs: generational poverty, high use of emergency rooms, ongoing need for community and crisis services, eviction and poor credit history, no transportation and frequent law enforcement interactions. All of these are factors that negatively affect a person’s ability to find and maintain stable housing, employment, and income.

We maintain low-barrier entry and follow Housing First best practices. We do not require participation in supportive services, minimum income, or sobriety for program entry. We do not exclude persons based on criminal history or sex offender status. We work closely with domestic violence providers to safely assist those fleeing. We offer scattered site and project based units. This reduces the length of time someone is homeless. MDMH critically reviews policies and procedures through a racial equity lens and adapts as guided by current racial equity best practices. MDMH participates in the Mental Health and Inclusion Alliance who advocate for equity and justice for historically marginalized and underserved populations in Missouri by educating and providing resources to individuals, groups, organizations and systems to disrupt racism, discrimination, and disparities.

Due to needs above, participants average 50 months in PSH to achieve housing and income stability. MDMH assesses participants for stability and moving on opportunities at least annually and creates a client-directed plan. Plans may include: applying to a PHA for subsidized housing, budgeting skills, reducing debt, overcoming obstacles that prevent moving on, such as a criminal record. Participants remain in SPC until they have completed their move-on plan. Some participants may have such high barriers and supportive service needs that moving on does not occur during the typical timeframe; we continue to serve them.

MDMH leverages resources of local mental health providers, PHAs, community and faith-based organizations to maximize services available and assure participants find housing that gives them the best access to transportation, treatment services, medical care, social services, child care, employment and other supports. This could include project based housing for those who otherwise wouldn't have timely access to safe, affordable housing options. Participants have access to SOAR-trained service providers and other service providers to assist with applying for mainstream resources including Medicaid, SNAP, SSI, SSDI, VA, Head Start, childcare assistance, vocational rehabilitation, and career centers.
