Great Circle's Empowering Home program will provide rapid re-housing to unaccompanied youth ages 17-24. A minimum of 5 youth will be provided supportive housing and additional support using a transition in place model, allowing them to live a more stable, safe, and pleasing life. Empowering Home will provide service 365 nights a year, providing a minimum of 5 scattered site rapid re-housing beds to unaccompanied youth in Greene, Christian, and Webster Counties. Direct case management will be provided in participants' homes, and a case manager will be available 24 hours a day, seven days a week by phone for all participants of the program. Additional services provided by Great Circle will include basic life skills training, connections to food and clothing assistance, behavioral health services, transportation, and other supports.

Eligible clients will be referred to the project through the Greene, Christian, and Webster Continuum of Care's coordinated entry system. We estimate the majority of clients will be referred through Great Circle's Empowering Youth emergency shelter and the The Kitchen, Inc.'s Rare Breed program, which provides similar drop-in and housing services. Within the first 72 hours of their referral to the program, each youth will complete an assessment in collaboration with the Empowering Home coordinator which discusses their housing, physical, medical, educational, and emotional needs. This assessment also includes a discussion of their history, family contact, screening for history of trauma or sexual exploitation, and the youth's short and long term goals. The Empowering Home coordinator and each youth will proactively review and modify these goals as needed during the youth's time in the program to meet additional challenges, needs, or opportunities which arise.

Youth will be housed within 30 days of program enrollment. Rental assistance may be provided not to exceed 12 months of assistance on units up to the Fair Market Rate (FMR) per month: \$467/month for an efficiency unit or \$522/month for a 1 bedroom unit. Utility assistance will be provided not to exceed 12 months of assistance. Rental security deposits, rental application fees, and utility security deposits will be paid on a one-time basis to secure housing for each youth served. Moving assistance will be provided to youth within 30 days of lease signing to move in furniture items and other necessities needed to ensure youth remain safely and sustainably housed. During the stated 12 months of financial assistance, youth will not be expected to or pay any portion of their rent or utilities. Once the youth is placed in permanent housing, housing stability
