Harmony House, located at 3404 E. Ridgeview Street in Springfield, MO is Springfield/Greene County's only domestic violence shelter. With 168 beds, we are the largest domestic violence shelter in the state, providing a comprehensive array of services, including 90-days emergency shelter; case management support; court advocacy; on-site domestic violence, substance abuse and children's counseling; on-site civil legal services; life skills classes & support groups; community outreach services; child care; transportation assistance; and housing assistance.

Our proposed renewal project would meet an ongoing need for rental assistance for domestic violence survivors moving from homelessness into safe, secure housing. Harmony House has been fortunate to receive funding from HUD for rental assistance, beginning July 1st, 2019. With our current HUD funding, we are able to cover the cost of first month's rent plus three months' short-term rental assistance for referrals pulled directly from our Continuum of Care's Coordinated Entry System Prioritization List of domestic violence survivors. Referrals are offered ongoing case management and support services through our Community Outreach Program even after they've secure housing.

This renewal will allow us to continue to support an ongoing, critical need for domestic violence survivors in our community and will enable Harmony House to not only provide housing assistance to more people but will also allow them the precious time necessary to become stabilized. Without HUD's continued funding, we will not be able to provide rental assistance to a vulnerable, underserved population.
