- 1. Match documentation The Kitchen, Inc. (TKI) had submitted documentation for the match. The confusion was that 25% of the full grant of \$311,717 was \$77,929.25. TKI spent \$255,596.57 of the award, and 25% of that is \$63,899.14. We had submitted documentation for \$65,505.52.
- 2. TKI's chart of accounts did not identify the federal grant number, CFDA and the year of the federal award in our accounting system.
- 3. The total dollar amount reported on grantees revenue and expenditures report and APR did not match.
- No self-assessment of the grantees internal control system has been completed.
- 5. TKI was unable to demonstrate that reasonable measures were taken to safeguard Personally Identifiable Information. (We did have policies in place and provided to HUD in our response.)
- 6. We did not have a system in place to provide documentation that HMIS was checked to ensure duplicate payments or improper payments were not made.
- 7. The request for proposal for audit services did not request the auditing organization's peer review and there was no evidence that positive efforts were made to utilize small business, minority-owned firms, or women's business enterprises.

Corrective actions:

- Match documentation was provided during the monitoring.
- 2. TKI is evaluating our current and different accounting software to address the need to identify grants using Federal ID within our accounting system. We are evaluating the current accounting system, policies, and procedures against 2 CFR 200 to always ensure we are using best practices in our financial management of grants.
- Check requests for expenditures were immediately updated to include the CFDA #, federal grant #, and fiscal year in addition to our internal tracking #.
- Our Director of Accounting recently identified how we could add the above information into our accounting system to clearly label reports drawn.
- 3. A Grant Closeout Procedure was written to provide step-by-step guidance, including where to locate HUD guidance, when completing grant closeouts.

For more than 38 years The Kitchen, Inc. (TKI) has provided housing and support services to individuals and families experiencing homelessness. TKI operates multiple housing programs through VA and HUD funding, including RRH and PSH programs for families, adults, and youth. All housing programs operate using a Housing First philosophy and a focus on reducing barriers to housing.

TKI strategically identifies housing programs to best meet the needs identified by the CoC in the community and works with the CoC's Coordinated Entry System to match households to the most effective housing program to hasten their return to stable housing. The CoC's front door, One Door, provides the initial assessment for households experiencing or at risk of homelessness, and provides referrals to TKI as necessary in order to match the most effective housing program to the household's situation.

This grant renewal application will support the leasing of 20 units of permanent housing to TKI's existing chronically homeless program, Chronic PSH. The program, which was developed in 2012 and implemented in 2013, was originally part of the CoC's 100K Homes efforts and follows their guidance by focusing on chronically homeless individuals with the highest vulnerability to dying on the streets. The 20 units are all dedicated to chronically homeless individuals. Support services are provided by a case management team trained in best practices, such as harm reduction and motivational interviewing. With their case manager, the head of household creates a Housing Stability Plan and receives referrals to resources that will help them maintain housing, such as health care and food bank resources. TKI recently signed an MOU with Burrell, a community behavioral health provider for eligible individuals ages 18 or older who have mental health, substance abuse, or other health care needs. Together, TKI and Burrell will facilitate easy access to health care systems in Springfield/Greene County for families who are uninsured, underinsured, and/or experiencing poverty or homelessness.

The goal of the Chronic PSH program is to provide housing to households experiencing chronic homelessness, so TKI can give them the time they need to stabilize their health and wellbeing. Through the program, TKI anticipates households to increase their income via employment, SSI/SSDI, food stamps, etc.; learn about community resources available to them; and learn how to access community-based services in the area.
