### 3B. Project Description

For more than 38 years The Kitchen, Inc. (TKI) has provided housing and support services to individuals and families experiencing homelessness. TKI operates emergency and rapid re-housing programs, including RRH for literally homeless families, singles, and unaccompanied youth. The RRH Families program was developed in 2012 and implemented in 2013 to serve families with children. TKI was a recipient of HPRP funds from the City of Springfield and originally developed the RRH program then. In 2013, TKI made a strategic decision to move the majority of its current site-based TH program for families to RRH using both ESG and HUD CoC funds. Currently the RRH Families program is run by TKI's Community Housing team.

TKI strategically identifies housing programs to best meet the needs identified by the CoC in the community and works with One Door, the CoC's coordinated entry system front door, to match households to the most effective housing program to their situation. This grant application for RRH Families would maintain 23 units of housing in TKI's existing RRH program. Last year, the RRH Families program served 135 people (46 adults and 89 children).

The program targets literally homeless families and rapidly moves them from homelessness to community-based housing and provides support services to help ensure the transition from homelessness is successful and sustainable. Households in the program can receive rental assistance and support services for up to 24 months. Support services include case management, which starts at the household's entry into the program and ends only at the household's exit. With their case manager, the head of household creates a Housing Stability Plan and receives referrals to resources that will help them find and/or maintain housing, such as health care and food bank resources. TKI recently signed an MOU with Burrell, a community behavioral health provider for eligible individuals ages 18 or older who have mental health, substance abuse, or other health care needs. Together, TKI and Burrell will facilitate easy access to health care systems in Springfield/Greene County for families who are uninsured, underinsured, and/or experiencing poverty or homelessness.

The goal of the RRH Families program is to provide rental assistance to households experiencing homelessness, so TKI can give them the time they need to stabilize. Through the program, TKI anticipates households to increase their income via employment, food stamps, etc.; learn about community resources available to them; and learn how to access community-based services in the area.
