According to Springfield Public Schools, out of 25,000 students, a total of 1,790 are McKinney-Vento eligible (2020). Additionally, of 102 youth surveyed in 2020's Springfield, Missouri Every Youth Counts event, 58 reported not knowing where they would sleep that night (Ozarks Alliance to End Homelessness). The Kitchen, Inc. (TKI) has worked with Springfield's population of homeless and atrisk youth since 2000 through our Rare Breed Youth Services center. In that time, TKI has provided housing to dozens of youth through the Rare Breed Youth Housing Program. In 2015, HUD granted funds for 9 RRH units to increase TKI's total youth beds to 28.

RRH Youth began in late 2017 under Rare Breed, but was moved recently to the Community Housing program. Though the RRH Youth program is now handled by our Community Housing team, it acts in collaboration with Rare Breed. In the previous funding period, TKI served 9 youth through the RRH Youth program, 2 of which have children. Funds received from this year's application will continue to provide rental assistance for these 9 units.

The RRH Youth program works with literally homeless youth who score 5-9 on the VI-SPDAT II and provides up to 24 months of assistance. The program is consistent with guidelines established by HUD for the RRH Families program. The PH component of the program serves youth who are the highest scoring on the VI-SPDAT and prioritizes youth that are chronic or have the longest periods of time homeless. TKI's RRH Youth program operates using a Housing First model. The program provides case management that is based on motivational interviewing and harm reduction and utilizes other best practices, including positive youth development and critical time intervention. Upon entry to the program, youth are assigned a case manager who helps them create a Housing Stability plan. Youth with diagnosed mental health or substance abuse disorders or who identify as LGBTQ+ can receive services through partner agencies if they desire and identify these services as part of their Housing Stability plan. All youth served by the program will receive housing counseling and services that include helping them locate a unit and successfully execute a lease or occupancy agreement. All youth are assisted in identifying community resources or partners that can provide services desired by the participants, such as local food banks, health care, Legal Aid, etc.

TKI's goal is to provide housing to homeless youth and through our housing program provide case management and supportive services that help these youth increase income, job skills, education, life skills, and more.
