Introduction

Crisis Cold Weather Shelters Survey

This report includes responses to a survey administered to individuals who sought shelter at one of Springfield's Crisis Cold Weather Shelters (CCWS) on the night of January 24, 2024. These emergency shelters are open October 1st through March 31st when temperatures are 32 degrees Fahrenheit or below. The Department of Housing and Urban Development specifies that individuals at these shelters count as sheltered rather than unsheltered for the federally mandated Point-in-Time (PIT) Count. Locally, however, the OAEH knows that for the rest of the year and on nights where temperatures are above 32 degrees, these individuals are typically unsheltered.

The first part of this report examines responses to the 2024 Crisis Cold Weather Shelters Survey conducted in Springfield and Greene County, Missouri, and provides information for 141 individuals who took shelter. This count reflects 112 individuals who either completed the survey instrument or who were observed, and 29 additional household members for whom survey takers provided information.

The data for the unsheltered population was collected primarily via electronic surveys created by the Institute for Community Alliances and administered by trained volunteers on January 24, 2024. Outreach surveys were also collected in a paper format and entered into the electronic form by Community Partnership staff. Data was organized in an Excel file before being imported into SPSS for statistical analysis.

This report presents findings from four major sections of the survey instrument: 1) Demographic Profile of Participants, 2) Homelessness Status, 3) Disabling Conditions, and 4) Victimization.

Demographic Profile of Participants

Most participants (71.4%) reported that they or their household members were aged thirty-five or older (Table 1). Men comprised 65.2% of the sample while women comprised 36.4% (Table 1). Most participants self-identified as being white (78.0%) and non-Hispanic/Latino (93.4%; Table 1). A small percentage of participants (13.7%) reported having served in the military (Figure 5). Of those who had served in the military, 9.4% served in the National Guard (Figure 6). However, most of these Veterans (82.4%) reported having never received healthcare or benefits from a Veterans Affairs medical center (Figure 7). About one-quarter of participants (27.2%) reported having been employed part- or full-time within the last six months (Figure 8).

Figure 1. Age of participants




Figure 2. Gender of participants




Figure 3. Race of participants




Figure 4. Ethnicity of participants




Figure 5. *Have you served in the military?*




Figure 6. Have you served in the National Guard?




Figure 7. Have you ever received healthcare benefits from a VA medical center?





Figure 8. Have you been employed recently, either part-time or full-time?



Homelessness Status


On the night of the Point-in-Time Count (January 24^{th} , 2024), participants took shelter at one of six CCWS locations (Table 2). Sixty-seven percent of individuals reported having been homeless continuously for a year or more at the time the survey was conducted (Table 3). Over half of participants (60.1%) met the HUD criteria for being considered "chronically homeless" (Table 4).



² In order to meet the criteria for chronicity, participants must have a disability and have been living in a place not meant for human habitation or emergency shelter for the last 12 months (continuously) OR on at least 4 separate occasions in the last 3 years where those occasions cumulatively total at least 12 months.

Disabling Conditions

Three-quarters of participants (74.6%) reported having at least one disabling condition (Table 5), while only 23.8% were receiving disability benefits of any kind (Table 8). Women were significantly more likely to report having a disability compared with men (Table 6). Although sample sizes were smaller relative to other racial categories, 84.6% of people in the Multiple Races group had a disability, with those in the Black, African American, or African category having the second highest percentage of people with a disability (Table 7). Mental health was the most cited disability (69.9%), followed by physical disability (49.5%), a chronic health condition (29.1%), drug abuse (14.6%), alcohol abuse (9.7%), a developmental disability (6.8%) and HIV/AIDs (1.0%; Table 10).





Victimization

Fifty-eight percent of participants reported having been a victim of domestic violence (Table 11). Women were significantly more likely to have ever been a victim of domestic violence than men (Table 12), and participants who reported having at least one disability were significantly more likely to report being domestic violence victims than non-disabled participants (Table 14). Of participants who reported that they had been a victim of domestic violence, 21.1% indicated they were currently fleeing (Table 15).




Table 12. Domestic Violence Victimization, by Gender


